A dated Veterinarian letter is required to verify injury, illness or bitches in season and must be submitted in writing to the Hunt Test Secretary. All requests for refunds must be made within (7) days after the Hunt Test. **There will be no refunds for no shows or requests after 7 days.** Please call, text or email the Hunt Secretary before the event begins for scratches.
