To receive a refund handlers must provide a certificate to the Hunt Secretary up to one week after the Hunt Test dates (unless reason for scratch is approved during the hunt test). No refunds are given for scratches for any other reason.

Owner/handlers may NOT substitute dogs for any reason after the Close date (2/18/25) without approval of the Hunt Secretary. If a handler removes a dog, for any reason, that running entry will be given to the next dog on the wait list, if any. A handler with multiple dogs who removes a dog may place another dog at the end of the wait list, if any.
