SCRATCHES

Scratches prior to closing date will be refunded by HuntSecretary.com unless Club Scratch Policy below states otherwise.

Scratches after the closing date, all scratches will be handled based on the Club Scratch Policy specified below.

CLUB SCRATCH POLICY

SCRATCHES

For scratches before the closing date, please contact Hunt Secretary at 281-924-5024 or email at support@huntsecretary.com.

After closing date, all scratches will be handled based on Club Scratch Policy stated here:

Full refunds shall be given for any scratch prior to closing of the early entry date.

Scratches after the closing of early entry policy is as follows: full refund will be given for female dogs in heat, for injury, illness or death, when certified by a veterinarian. No action will be taken until the Hunt Test Secretary receives a written request including dogs name, test entered, whom to make refund check payable, address to mail refund, written vet excuse on clinic letterhead and signed by vet. There are no refunds for no-shows.

Female dogs in heat shall not be allowed to enter or participate in the hunt test(s). The club shall follow the standard set forth by the UKC/HRC regarding female dogs in heat with the following club revisions:

1. All females suspected of being in heat during the day of the event shall be checked on site by the club appointed committee member or on-site vet technician.
2. If a female is found to be in heat during the event, checked and verified by the club appointed committee member or on-site vet technician and PRIOR to running, the dog shall not be allowed to participate any further. All entry fees for that dog shall be refunded.
3. If a female is found to be in heat during the event, checked and verified by the club appointed committee member or on-site vet technician and AFTER running any part of the test, the dog shall not be allowed to participate any further. All entry fees for that dog shall be forfeited.

SWAPPED ENTRY POLICY

THERE IS NO SWAPPING OF DOGS AFTER CLOSE DATE Eastern Carolina Hunting Retriever Club does not allow dogs to be swapped. If a dog has been entered and cannot run, then that entry falls under the scratch policy. If the owner/handler wishes to enter a dog in lieu of the scratched dog, they may do so, however, the new entry must have a new premium to enter along with a new entry fee. If the original entry is scratched and was entitled to a refund under the club scratch policy, that refund may be used for the new dog's entry.
